Tuition-Related Miscellaneous Charges for Academic Year 2009-10

IMPORTANT NOTE:

Starting in summer 2009, the University of Iowa is implementing a new method of assessing tuition and fees for Distance Education/Extension (Web, Off-Campus, Guided Independent Study) courses. Students who enroll in distance education courses *only* (**see list of exceptions below) will be assessed resident or nonresident tuition and the mandatory computer fee based on their program of study and semester hours of enrollment. Students who enroll in distance education courses *and* one or more on-campus courses will be assessed resident or nonresident tuition and all mandatory fees based on their program of study and their total semester hours of enrollment.

****Exceptions:** The new method of assessing tuition *and* fees does not apply to: Public Health off-campus; RN-to-BSN off-campus; MBA for Professionals & Managers; workshop enrollments; Lakeside Lab enrollments; or CIMBA (Consortium Institute for Management and Business Analysis).
