ILA/ACRL Officer Candidates

Beth McMahon (candidate for Vice President/President-Elect)

Biography: Beth McMahon is Director of Geisler Library at Central College. Before being appointed as Director in 2014, she worked as Reference and Instruction Librarian at Central College 2006-2014. She holds a B.A. in Women's Studies and Peace Studies from Antioch College, an M.A. in Women's Studies from The Ohio State University, and an M.L.I.S from Kent State University. Before moving to Iowa, she held professional library positions at Earlham

College (Indiana) and University of Dayton (Ohio). Beth has been a member of ILA/ACRL since arriving in Iowa, and has served the organization as Chair of the Spring Conference Committee in 2010 and 2011 and as a current member of the Newsletter Committee. She has completed the ACRL Institute for Information Literacy (2008), Harvard Institute for Higher Education's Library Leadership in the Digital Age program (2014), and ACRL's New Library Director Mentor Program (2015).

Statement: The vitality of our statewide academic library community is one of the things that has sustained me in my professional development since I arrived in Iowa almost a decade ago. I am continually impressed by the talent and energy present in this organization and across our state. I am honored and excited to accept nomination for the position of Vice President/President Elect of ILA/ACRL in hopes of making a useful contribution to sustaining and energizing our organization.

University of Dubuque

The Library will hold a “Mo Willems Story Time” for preschoolers on Saturday, October 3. Becky Canovan and Diana Newman run this very popular preschool story hour program. Grand View University

Cara Stone, Faculty Development & Instruction Librarian, and Dan Chibnall, User Services & Instruction Design Librarian, traveled to the Indiana University Libraries Information Literacy Colloquium, held August 7 in Kokomo, IN, where Stone co-led a workshop with Becky Canovan (University of Dubuque): The Information Literacy Constellation: How Do Your Stars Align? Cara Stone and English faculty member Amy Getty have been invited to present at the Council of Independent Colleges' (CIC) Workshop on Information Fluency in English and American Language and Literature, to be held March 10-12, 2016, in Louisville, KY.

Around campus there has been much excitement regarding the newly completed Jensen Bridge Skywalk and Student Center. The Jensen Bridge connects the new Student Center to the Rasmussen Center, extending across busy East 14th Street. On May 7th at 1:00 a.m. a celebration was held as the two halves of the structure were connected, with much work continuing through the summer to enclose and put the finishing touches on the Jensen Bridge. A ribbon cutting ceremony for the skywalk will be held Thursday, September 17. In addition, the recently-completed Student Center now serves as a central hub for campus, not only housing the Bookstore, Dining Services, Student Support Services, Academic Advising and Enrichment, Campus Services, Speech & Theatre programs, and Student Life, but also became a new home for the Communications Department, and expanded GV's offerings by adding additional event hosting spaces. We are also excited about the new programs connecting Grand View with international partnerships in China and Denmark, creating opportunities for student and faculty exchanges.

Kirkwood Community College

Kirkwood Community College's Iowa City Campus received a \$10,000 grant from the NEH and ALA, Latino Americans: 500 Years of History, in support of programming that highlights Latino American history and culture. 

Weeding Continues

We weeded again this summer – our entire 3rd floor and a portion of 4th floor. These floors included two of the toughest sections for us to weed – American and British Literature. But we feel we did a pretty good job. This time around, we weeded 13,200 books to go along with the 14,590 that we weeded in the summer of 2014. One more summer and we'll make it through the entire collection – picking the low-hanging fruit – those things that haven't circulated for over 20 years and are older than 1990. This is no small feat – just a reminder – we have well over 300,000 books in our collection!

We found lots of interesting things while we were doing this. Donations often made some sections unintentionally lopsided; Sears gave out grants to buy books in the 60s and we evidently received a number of them; many books were checked out when we first got them, but then were never looked at again; we found a cute little poem on some of the older book pockets:



And we also found a number of property stamps that matched the changing times and names of the college:



Finally, I would highly recommend that everyone go out in the stacks and weed in context. It's a great learning experience – much more effective than trying to just weed from a list of books. We started with the list but moved to the stacks to actually evaluate the list. It's time consuming, but again, worth it.

Emergency Plan

Heidi Pettitt, Special Collections and Technical Services Librarian attended ACRL in Portland this spring and went to a great session about disaster/emergency plans. So this summer, she and Kristen Smith, E-Resources & Research Services Librarian, updated our disaster plan. Our old plan had different people named for specific tasks but if that person wasn't here, then we weren't always sure who was supposed to do what. Our new plan has a self-appointed point person who delegates tasks based upon a checklist depending upon the emergency and the available staff. We sure hope this works! I've been at Loras for 11 years now and we've had the pipes break 4 times – so far that's the extent of our "emergencies".

Hawkeye Community College

The Hawkeye Community College Library is migrating to Alma and Primo (ExLibris) along with the other academic libraries of the Cedar Valley Library Consortium (UNI, Wartburg College and Allen College). Migration work will begin in earnest in November with a go live date tentatively slated for mid-late May 2016.

As Central College's Integrated Learning initiative moves into the implementation phase, Integrated Learning Librarian Mary Anderson took on the challenge of training the entire incoming class of students (plus their RAs and other student leaders) to use the new electronic portfolio system in just under two weeks! Congratulations to Mary for accomplishing this demanding task and leading the students in this new educational initiative.

Library Director Beth McMahon will present with Central College Director of Writing Dr. Susan Pagnac at the International Writing Center Association conference in October, 2015. They will present as part of the the panel discussion "(R)evolution through Collaborations: Interdisciplinary Connections of Writing Centers to Increase Student Engagement."

Geisler Library welcomes our new Student Intern Jasmine Fugate. Jasmine will gain experience in many different parts of the library and she prepares to enter an MLIS program after graduation from Central College. We also welcome back our Reference Assistant Mackenzie Uhlenhopp, who is now also a graduate student in Music Therapy at the University of Iowa.

Lastly, Geisler Library has committed to converting from III Millenium to OCLC World Share. Technical Services Librarian Kyle Winward is already working hard preparing the way for this exciting transition, slated to go live in May 2016.

Special Libraries News

Iowa Library for the Blind and Physically Handicapped

BARD: Braille and Audio Reading Download

BARD, the Braille and Audio Reading Download from the National Library Service, is a web-based service that provides access to thousands of special-format books, magazines, and music-scores to library patrons. BARD now has both iOS and Android free apps available. The BARD

Mobile app enables users to download audio books and audio magazines directly to their iOS and Android devices. The iOS app also allows users to download and read electronic braille.

New Braille Code

On January 4, 2016, the National Library Service (NLS) will implement the Unified English Braille (UEB) code, which is the first extensive change to braille code since the 1930's. The new code uses the same six dot cell pattern, but drops some contractions, uses different spacing rules, and allows for translating a wider array of symbols. UEB brings Braille into the computer age. It will be especially beneficial to students and other users of technology, as it will help improve translations from print to Braille and Braille to print. NLS has already acquired over 90 electronic titles in UEB and has posted them onto BARD (Braille and Audio Reading Download). Existing books in the current braille code (English Braille American Edition) will remain in the NLS braille collection and will still be available to patrons. The Iowa Library for the Blind and Physically Handicapped will also be adding UEB titles to their collection as well.

Robert Becker Memorial Library at Seed Savers Exchange, Decorah, IA

Seed Savers Exchange's Robert Becker Memorial Library hosted the 47th Annual Meeting the national Council on Botanical and Horticultural Libraries (CBHL) June 16-20. A total of 55 CBHL members and guests from diverse botanical and horticultural libraries across the U.S. and Canada gathered in Decorah to explore the topic "Taste, Tradition and Beauty in the Edible Landscape."
